

ORDER

1. WHEREAS in terms of section 14(3) (a) of the NCTE Act, 1993 WRC granted recognition to ANAND INSTITUTE OF MANEGMENT, 51/2, 52/2, VIJAY NAGAR, LALGHATI ABOVE HYUNDAI SHOWROOM BHOPAL, MADHYA PRADESH for B.ED course of 1 year duration with an annual intake of 100 students vide order No.WRC/2-32/223224/74/2005/4901 dated . 27.06.2005.
2. AND WHEREAS the said recognition was withdrawn by WRC vide order No.WRC/MP/Legal/APW01157/223224/115/2009/53414-53419 dated 8.04.2009 and the institution had preferred an appeal against the order of WRC before the Council (NCTE) New Delhi, u/s 18 of NCTE Act, 1993. The Council had passed order dated 18.08.2009 and remand back to WRC for consideration of the inspection report of new premises.
3. AND WHEREAS in compliance of appeal order the inspection of new premises of the institution was conducted and report was considered by WRC and WRC decided that the institution is treated as recognized and shifting to the new premises permitted.

NOW THEREFOR, in exercise of the power vested under section 14 (3) (a) of NCTE Act, 1993, the WRC hereby restore the above recognition to ANAND INSTITUTE OF MANEGMENT, 51/2, 52/2, VIJAY NAGAR, LALGHATI ABOVE HYUNDAI SHOWROOM BHOPAL, MADHYA PRADESH for B.ED course and permission u/s 8(11) of NCTE Regulation 2009 is hereby granted to said institution to change the premises from ANAND INSTITUTE OF MANEGMENT, 51/2, 52/2, VIJAY NAGAR, LALGHATI ABOVE HYUNDAI SHOWROOM BHOPAL, MADHYA PRADESH to ANAND INSTITUTE OF MANEGMENT, GRAM BARKHEDA NATHU NEAR- NEELBAD BHOPAL, MADHYA PRADESH for conducting above recognized course with immediate effect.




